Where do we stand?

In the initial phase of the project, each country partner carried out **National Research** to obtain precise information on the state of the art of training courses aimed at meeting the learning needs of professionals, trainees and VET students in the maintenance sector for four strategic categories: Augmented Reality (AR), Virtual Reality (VR), 3D Printing and Lean Manufacturing.

The period following the summer break saw instead the consortium complete an extremely important phase in the process of fine-tuning the essential elements for achieving the project objectives. With the direction of TECOS, each partner contributed to the structure of the 1Point training course curriculum, which is primarily inspired by Total Productive Maintenance (TPM), a holistic approach to equipment maintenance that strives to maximise effectiveness in production.

The first results of this analysis, mainly focused on maintenance in the field of Lean Manufacturing used as common approach to define the entire 1Point methodology, are included in the **Training Methodology Report** that has taken shape in recent weeks.

We will keep you updated on the development of this activity, which will lead us in the coming months to complete the course and test its effectiveness with VET students and maintenance professionals already involved in production processes.
